During the quarter and nine months ended December 31, 2019, pursuant to the amendment in Ind AS-23 "Borrowing Costs", the Company has considered the specific borrowings obtained for completed phases as a part of general borrowings. Accordingly, the finance cost amounting to ₹ 1,176.40 lakhs and ₹ 2,750.40 lakhs for the quarter and nine months ended December 31, 2019 respectively related to such borrowings has been capitalised as a part of Capital Work in Progress. This has resulted in increase in the Basic & Diluted Earnings per Share (not annualised) by ₹ 0.86 and ₹ 2.01 for the quarter and nine months ended December 31, 2019 respectively.

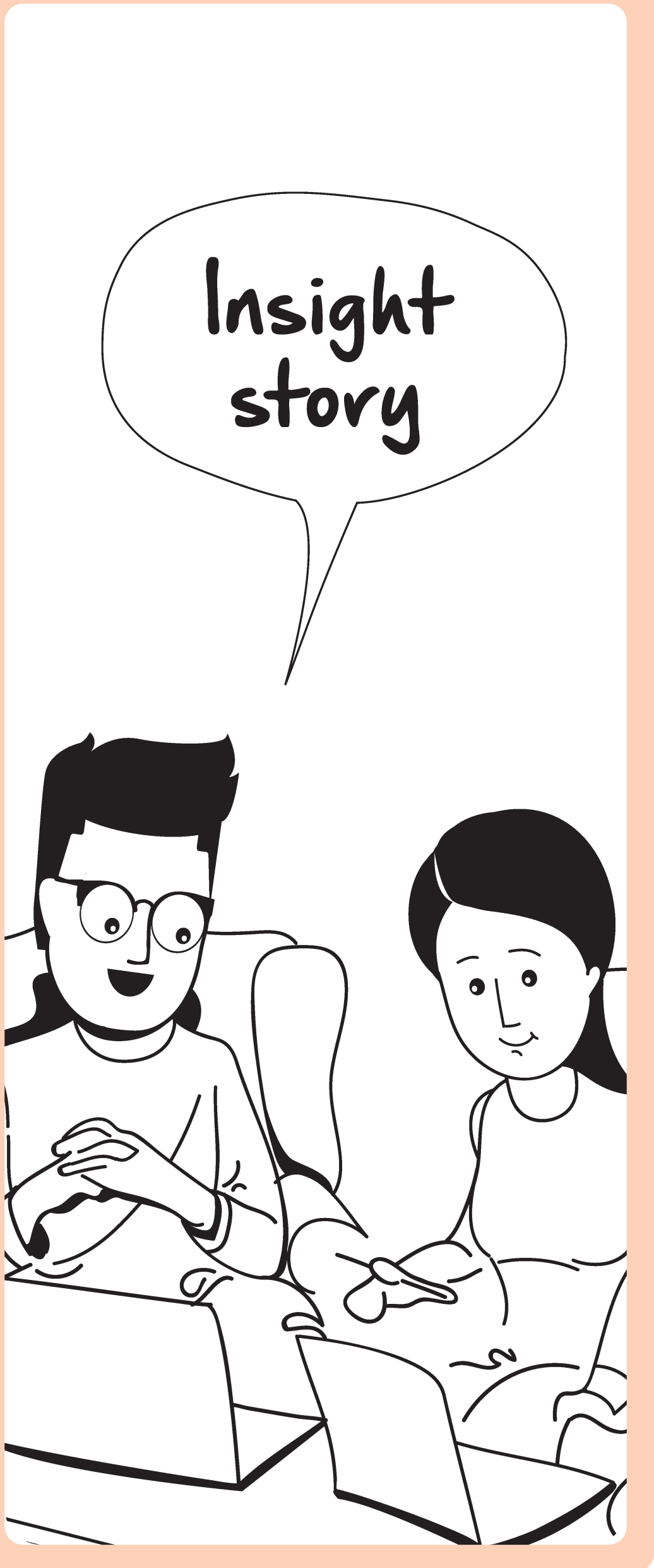
