रेवाड़ी। स्थानीय हुडा बाईपास स्थित एक होटल के सेफ्टी टैंक की खराब मोटर को बाहर निकालने के लिए उतरे होटल के सैफ व मिस्त्री की जहरीली गैस में दम घुटने से मौत हो गई। कडी मशक्कत के बाद दोनों शवों को पुलिस ने दमकल कर्मियों की मदद से बाहर निकाला।

जानकारी के अनुसार हुडा बाईपास स्थित एक होटल के बाहर बने सेफ्टी टैंक की मोटर कुछ दिनों से खराब पड़ी हुई थी, जिसके कारण गंदा पानी नहीं निकल रहा था। मोटर को ठीक कराने के लिए होटल की तरफ से गांव बवाना गुर्जर निवासी रामजस

(28) को बुलाया गया। सोमवार दोपहर रामजस होटल पहुंचा। होटल की तरफ से मोटर को बाहर निकालने में रामजस की मदद करने के लिए बिहार के दरभंगा निवासी 22 वर्षीय देवेन्द्र को भी लगा दिया गया। देवेन्द्र होटल में बतौर सैफ काम कर रहा था। दोनों ने सेफ्टी टैंक को खोल लिया। उन्होंने मोटर को तो ऊपर खींच लिया। लेकिन टैंक की गंदगी साफ करने के लिए उतरा रामजस वापस नहीं आया। उसके बाद उसे देखने के लिए नीचे उतरा देवेंद्र भी बेहोश हो गया। काफी देर बाद भी जब दोनों बाहर नहीं आए तो होटल के कर्मचारी वहां पहुंचे।

देखा तो वे दोनों अंदर थे। कर्मचारियों की सूचना पर तुरंत पुलिस मौके पर पहुंची और दमकल कर्मियों की मदद से दो घंटे बाद दोनों को बाहर निकाला गया, लेकिन तब तक दम घुटने से उनकी मौत हो चुकी थी। मॉडल टाउन थाना प्रभारी बिजेंद्र कुमार ने कहा कि मामले की जांच की जा रही है। परिजनों के आने के बाद ही आगे की कार्रवाई की जाएगी। दोनों शव पोस्टमार्टम के लिए शवगृह में रखवा

रेवाड़ी। कस्बा बावल में सोमवार दोपहर को हथियारबंद बदमाशों ने एक पेट्रोल पंप कैशियर से पिस्तौल के बल 16 लाख रुपए लूट लिए। लूट की सूचना मिलने के बाद पुलिस विभाग में हडकंप मच गया। जानकारी के अनुसार बावल ब्लॉक समिति के चेयरमैन विरेंद्र छिल्लर का कैशियर योगेश कुमार ब्रिकी के 16 लाख रुपए लेकर बैंक में जमा कराने के लिए कार में निकला था। जब वह हाईवे स्थित चांदूवास पुल के नीचे से गुजर रहा था तो सामने से आ रही एक पिकअप ने उसकी कार को टक्कर मार दी, जिसके बाद बाइक पर सवार एक युवक वहां आ गया। तत्पश्चात पिकअप व बाइक चालक दोनों ने पिस्तौल निकाल ली और बट मारकर योगेश को घायल कर दिया। बदमाशों ने कार में रखा 16 लाख रुपए का बैग लूट लिया और पिकअप को वहीं छोड़कर फरार हो गए।

बताया जा रहा है कि यह पिकअप बीती रात 3 बजे नैहचाना से चोरी हुई थी, जिसके मालिक ने रिपोर्ट दर्ज करा रखी है। बावल पुलिस व सीआईए धारुहेडा व रेवाडी पुलिस मौके पर पहुंचकर जांच में जुट गई। बावल थाना प्रभारी मदनलाल ने बताया कि कैशियर योगेश की शिकायत पर केस दर्ज कर लिया गया है और जांच शुरू कर दी गई है।

जींद। गांव खेडा खेमावती में पांच साल पहले सुपारी लेकर महिला की हत्या करने के तीन आरोपित को सफीदों थाना पुलिस ने गिरफ्तार किया है। गांव खेड़ा खेमावती निवासी सुनील की पत्नी ज्योति की 30 अक्टूबर को घर में ही तेजधार हथियार से हत्या कर

पुलिस ने मृतका के जेठ सोमा उर्फ सोमपाल की शिकायत पर संदीप व एक अन्य के खिलाफ हत्या का केस दर्ज किया था। पुलिस को मृतका ज्योति के जेठ तथा ज्योति हत्या के शिकायतकर्ता सोमपाल पर संदेह हुआ। पुलिस ने आरोपित से जब सख्ती से पूछताछ की तो उसने ज्योति की हत्या की बात स्वीकार कर ली।

पुलिस पूछताछ में सामने आया कि आरोपित सोमपाल की पत्नी पूजा तथा सोमपाल के छोटे भाई सुनील की पत्नी मृतका ज्योति सगी बहुनें थी। वर्ष 2011 में सोमपाल के छोटे भाई सुनील की मौत हो गई।

सोमपाल को संदेह था कि उसके भाई सुनील की मौत के पीछे ज्योति का हाथ है। सोमपाल ने सुनील की पत्नी ज्योति की हत्या का षड्यंत्र रचा और गांव रावर करनाल निवासी दिव्यांग मंगतराम को साढ़े तीन लाख रुपए हत्या की सुपारी का ऑफर किया, जिसमें डे-ढ़ लाख रुपए मंगतराम को दे दिए गए। मंगत ने गांव रावर निवासी संदीप तथा प्रदीप को ज्योति की हत्या के लिए हायर कर लिया।

30 अक्टूबर, 2014 को दोनों आरोपित ज्योति के मकान पर पहुंचे। प्रदीप ने ज्योति के पेट में तेजधार हथियार घोंप दिया, जबकि संदीप ने तेजधार हथियार से गर्दन पर वार कर दिया। वारदात को अंजाम देकर दोनों फरार हो गए थे। पुलिस ने कार्रवाई करते हुए आरोपित सोमपाल को गिरफ्तार कर लिया था, जबकि सोमपाल, गांव रावर करनाल निवासी मंगतराम, प्रदीप तथा संदीप फरार चल रहे थे। पुलिस ने कार्रवाई करते हुए तीनों को गिरफ्तार कर लिया। पुलिस आरोपितों से पूछताछ कर रही है।

चुनाव से पहले नशे के सौदागरों पर हरियाणा पुलिस की बडी कार्रवाई

चंडीगढ। पुलिस द्वारा चुनाव से पहले मादक पदार्थ तस्करों व अन्य अपराधियों को काबू करने के लिए बनाई गई रणनीतियां कारगर रही हैं। पलिस ने राज्यभर में एक माह चले एक विशेष एंटी-डग अभियान के तहत 386 मामले दर्ज कर 483 लोग को गिरफ्तार किया। इस दौरान 1204 किलोग्राम से अधिक मादक पदार्थ जब्त किए गए हैं।

पुलिस महानिदेशक मनोज यादव ने सोमवार को यहां यह जानकारी देते हुए बताया कि विधानसभा चुनाव की घोषणा से पहले मादक पदार्थों की आपूर्ति के नेटवर्क को तोड़ने व इसमें संलिप्त नशा कारोबारियों को काबू करने के लिए पलिस द्वारा 20 अगस्त से 20 सितंबर तक एक विशेष अभियान चलाया गया था। इस अवधि के दौरान, सभी पुलिस आयुक्त और जिला पलिस अधीक्षकों को अपने-अपने क्षेत्रों में मादक पदार्थ की तस्करी व इसके वितरण नेटवर्क को पूरी तरह से कुचलने के लिए निर्देश दिए थे।

डीजीपी ने कहा कि इस दौरान पुलिस ने गिरफ्तार आरोपियों के कब्जे से 559 किलो 719 ग्राम गांजा, 1 किलो 826 ग्राम से अधिक हेरोइन, 630 किलोग्राम 618 ग्राम चूरापोस्त, 5 किलो 648 ग्राम अफीम, 3 किलो 531 ग्राम चरस, 2 किलो 710 ग्राम से अधिक स्मैक और 458 ग्राम 750
