

चंडीगढ़। पंजाब एवं हरियाणा हाईकोर्ट ने नूंह और गुरुग्राम चंडीगढ़। हरियाणा सरकार द्वारा पंजाब भू परिरक्षण में अतिक्रमण हटाने के खिलाफ स्वतः संज्ञान लेने के मामले अधिनियम 1900 (पीएलपीए) में संशोधन के बिल में सुनवाई स्थगित कर दी है। शुक्रवार को चीफ जस्टिस रवि को संशोधित करने को चुनौती देने वाली याचिका शंकर झा व जस्टिस विकास बहल पर पंजाब एंव हरियाणा हाई कोर्ट ने वन भिम पर की पीठ के सामने जैसे ही सुनवाई किसी भी गैर वन्य कार्य को रोकना सुनिश्चित करने शुरू हुई काफी संख्या में प्रभावित का हरियाणा सरकार को आदेश दिया है। साथ ही लोगों की तरफ से अर्जी दायर कर इस मामले में अगली सुनवाई 11 दिसम्बर पर हरियाणा सरकार को स्टेट्स रिपोर्ट सौंपनी होगी। पक्ष बनाने की मांग की गई। कोर्ट ने पीएलपीए के आधीन क्षेत्रों में कोई निर्माण कार्य व किसी तरह का आदेश जारी न करते हुए मामले की सुनवाई स्थगित कर अवैध खनन को रोकने के लिए शिवालिक विकास दी। इससे पहले हरियाणा सरकार मंच के अध्यक्ष एडवोकेट विजय बंसल हाई कोर्ट कोर्ट में जवाब दायर कर कह चुकी है कि नृंह और गुरुग्राम याचिका दाखिल की है। याची ने बताया कि उसने में अतिक्रमण हटाओ अभियान चलाने से पहले कानून के आरटीआई के माध्यम से जानकारी मांगी थी जिसमें तहत उचित प्रक्रिया का पालन किया गया था। सरकार के बताया गया कि वन विभाग के अतिरिक्त मुख्य हलफनामे के अनुसार, पांच विभागों ने सात अगस्त तक सचिव व विधानसभा स्पीकर ने 20 अगस्त 2019 अपने-अपने क्षेत्रों में अतिक्रमण विरोधी अभियान चलाया। को बताया था कि संशोधन बिल पर राज्यपाल की ध्वस्त की गई कुल निर्माण 443 थे, जिनमें से 162 स्थायी सहमति आना बाकी है जबिक राज्यपाल ने रिकार्ड और 281 अस्थायी थे। इसी प्रकार अतिक्रमण विरोधी के अनुसार 11 जून 2019 को इस बिल को सहमति

दे दी गई है।
